THIS IS A LEGAL AGREEMENT BETWEEN YOU AND/OR THE COMPANY YOU REPRESENT AND MIGRATION SPECIALTIES INTERNATIONAL. IF YOU DO NOT CARE TO BE BOUND BY THIS AGREEMENT, DO NOT INSTALL THE SOFTWARE.

1. DEFINITIONS

- "License Key", "License Dongle", "USB Dongle", or "USB Key" = USB device that controls software licensing and usage.
- "Avanti" = "Software" = Really great product!

2. LICENSE GRANTS

- The license grants non-exclusive rights to use the Software.
- The Software may be copied and backed up as required for internal use.
- The Software will only run on the system that contains the License Key.
- Migration Specialties reserves the right to audit usage, so be good.

3. LICENSE RESTRICTIONS

- Aside from configuration files, you may not alter the Software.
- Doing any of the following will get you in trouble.
 - Changing the host system date and time to an earlier time (back dating) may disable the license key. Back dating a host system to circumvent license limits violates the EULA.
 - Reverse engineering the Software.
